Definition of IFRA 1	Children’s toys. Lip products of all types (solid and liquid lipsticks, balms, clear or coloured, etc.).
Definition of IFRA 10A	Hand wash laundry detergent (including concentrates). Laundry pre-treatment of all types (e.g. paste, sprays, sticks). Hand dishwashing detergent (including concentrates). Hard surface cleaners of all types (bathroom and kitchen cleansers, furniture polish, etc.). Machine laundry detergents with skin contact (e.g. liquids, powders) including concentrates. Definition of IFRA 3	Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer. Facial make up and foundation. Make-up remover for face and eyes. Nose pore strips. Wipes or refreshing tissues for face, neck, hands, body. Body and face paint (for children and adults). Facial masks for face and around the eyes.
Definition of IFRA 4	Hydro alcoholic and non-hydro alcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancng cream, aftershaves of all types, etc.).
