Definition of IFRA 1	Children's toys. Lip products of all types (solid and liquid lipsticks, balms, clear or coloured, etc.).

Definition of IFRA 3	Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer. Facial make up and foundation. Make-up remover for face and eyes. Nose pore strips. Wipes or refreshing tissues for face, neck, hands, body. Body and face paint (for children and adults). Facial masks for face and around the eyes.
Definition of IFRA 4	Hydro alcoholic and non-hydro alcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragancing cream, aftershaves of all types, etc.).
